2. Teaching of Punjabi will be compulsory in your school and that CBSE shall make efforts to conduct examination for Punjab and that in the event of non abeyance of this , NOC will be with drawn immediately.
3. The school management will obey Notification as it is issued by Education Department of Punjab- RTE Act 2009 and its Rules which are applicable to Punjab state – RTE Act 2009.
4. After obtained the affiliation from CBSE, New Delhi, Management of the school will pay salary and allowance to teaching and non-teaching staff at par with those in the Govt job and in the event of non observance of the same, NOC will be withdrawn immediately.
5. You and your management will ensure that when ever any information is sought by Dist. Education officer or any other officer of Education Deptt, the same will be provided and also the necessary co-operation will be given.
